

# Shocking Legal Document Shows Pharma Giants, Fauci and Elites Accused of Crimes Against Humanity in International Criminal Court



In a 46-page legal filing to the [International Criminal Court](#) (ICC) on Dec. 6, a human rights attorney on behalf of seven applicants accused Dr. Anthony Fauci, the CEOs of Pfizer, Moderna and Johnson & Johnson (J&J), Bill Gates and 11 others of violating the [Nuremberg Code](#) and articles 6, 7, 8, 15, 21 and 53 of the Rome Statutes, which define [crimes against humanity](#), crimes of aggression, genocide and other crimes.

In 1998, six countries signed on to a statute, which laid the foundation for the establishment of the ICC, whose purpose is to investigate and prosecute those accused of war crimes, crimes against humanity and genocide.

The applicants, which include Dr. Michael Yeadon, former vice

president and chief scientist of allergy and respiratory research at Pfizer, have asked the ICC for an immediate injunction halting the rollout of COVID vaccines, vaccination passports and “other types of illegal warfare mentioned herein currently being waged against the people of the United Kingdom.”

Alleged perpetrators include UK Prime Minister Boris Johnson, chief medical officer for England and chief medical adviser to the UK government Christopher Whitty, former secretary of state for health and social care Matthew Hancock, secretary of state for health and social care Sajid Javid, chief executive of Medicines and Healthcare products Regulatory Agency June Raine, director-general of the World Health Organisation Tedros Adanhom Ghebreyesus, Bill Gates, Melinda Gates, Pfizer CEO Albert Bourla, AstraZeneca CEO Stephane Bancel, CEO of Moderna Pascal Soriot, CEO of J&J Alex Gorsky, President of the Rockefeller Foundation Dr. Rajiv Shah, Director of the National Institute of Allergy and Infectious Disease Dr. Anthony Fauci, executive chairman of the World Economic Forum Klaus Schwab, and Dr. Peter Daszak, President of EcoHealth Alliance.

The ICC has acknowledged the case and assigned it reference number OTP-CR-473/21. The allegations contained in the document are shocking, but not surprising to anyone who has witnessed the events of the COVID pandemic play out on a global scale.

## **Allegations made to the International Criminal Court**

- COVID vaccines do not meet the requirements to be categorized as vaccines and “are in fact gene therapy,” evidenced in part by the change in the definition of “vaccine” to include components of mRNA injections.

- The long-term effects of COVID vaccines are ongoing and unknown. Potential long-term effects can take months or years to manifest and child trials were not equipped to rule out uncommon but severe side effects.
- All Phase 3 COVID vaccine trials are ongoing and do not conclude until late 2022/2023. RNA vaccine technology has never been previously used in humans and is entirely experimental.
- COVID vaccines are a “public manipulation and misrepresentation of clinical treatment,” are not vaccinations, do not prohibit infection and are “conscripted to make a toxin.” The spike protein could accumulate in the body, and if the immune system attacks the location where it accumulates, could cause auto-immune disorders.
- A review from the University of Oxford’s Centre for Evidence-Based Medicine found standard PCR test is so sensitive, it can detect old infections by picking up fragments of dead viral cells. The Public Health England policy confirms that the cycle threshold should be set around 25.6. According to freedom of information act (FOIA) requests, 40-45 cycles are being used, which increases the chance of a positive result.
- COVID is a biological weapon and product of gain of function research. The “novel coronavirus” was developed “as a laboratory product created by using bat coronaviruses ZC45 and/or ZXC21 as a template and/or backbone,” and publications have caved to political pressure or have conflicts of interest so as not to publish findings that differ from natural origin theory.
- British Professor Angus Dalglish and Norwegian scientist Dr. Birger Sørensen published a report in the Quarterly Review of Biophysics claiming the COVID spike protein contains sequences that appear to be

artificially inserted. They claim to have had 'prima facie evidence of retro-engineering in China' for a year but were ignored and rejected by academics and major journals.

- COVID vaccines contain graphene hydroxide, which acts as "razor blades" inside the veins of "vaccine recipients." Graphene oxide structures do not show up on autopsies, as toxicologists aren't looking for structures that can cut up blood vessels causing people to bleed to death on the inside. The German chemist and top EU graphene expert who discovered the problem was attacked and murdered shortly after publishing his latest video on graphene oxide and graphene hydroxide.
- The number of COVID cases has been artificially inflated due to the inaccuracy and unreliability of PCR tests leading to "massively artificially inflated" COVID death numbers. A death is recorded as a COVID death if the person dies for any reason within 28 days of a positive COVID test even if COVID was not the factual cause of death. A FOIA request revealed 4,476 COVID-related deaths between March and June 2020 in England and Wales in individuals with no pre-existing conditions, but COVID deaths for the same period were recorded as 49,607.
- COVID statistics "have been artificially inflated is by the 'rebranding' of common influenza, pneumonia and other respiratory infections as COVID-19." For example, data show that deaths in 2018 from influenza and pneumonia amounted to 29,516 and in 2019, was 26,398. However, there were only 394 deaths in 2020 attributed to flue and 13, 619 to pneumonia.
- One of the joint applicants, a funeral director, said a "massive effort was made to deliberately inflate COVID death numbers. Cancer patients and stroke victims and

even one guy that was run overall ended up with COVID on their death certificate.”

- The World Health Organization admitted there is no evidence showing masks protect non-sick individuals from COVID.

“In addition to hypoxia and hypercapnia, breathing through facemask residues bacterial and germ components on the inner and outside layer of the facemask. These toxic components are repeatedly breathed back into the body, causing self-contamination,” the complaint states.

“Breathing through facemasks also increases temperature and humidity in the space between the mouth and the mask, resulting in a release of toxic particles from the mask’s materials. A systematic literature review estimated that aerosol contamination levels of facemasks including 13 to 202,549 different viruses.”

- The World Economic Forum (WEF) partnered with Johns Hopkins in May 2018 to simulate a fictitious pandemic called ‘Clade X’ to see how prepared the world be if faced with a catastrophic pandemic. The WEF in Oct. 2019, teamed up with Johns Hopkins and the Bill and Melinda Gates Foundation to stage another pandemic exercise called ‘Event 201,’ which simulated a COVID outbreak. Five months later the WHO declared COVID had reached pandemic status.

Since then, every scenario covered in the Clade X and Event 201 simulations has come into play, including worldwide lockdowns, collapse of many industries, mistrust between government and citizens, adoption of biometric surveillance technologies, social media censorship in the name of combating misinformation, flooding communication channels with “authoritative sources,” global lack of personal protective equipment, breakdown of supply chains, mass unemployment and

rioting. Klaus Schwab, founder of the WEF declared the pandemic as an opportunity for a “great reset” – a new world order.

- Beginning in 2020, social media platforms have censored and suppressed COVID-related information that goes against the WHO, as Event 201 recommended. Authorities have blocked legitimate websites and ordered the removal of unwanted content. There has been an unprecedented assault on the freedom of doctors to care for their patients and publications have blocked the publication of studies showing the effectiveness of drugs like ivermectin and hydroxychloroquine.
- Governments and NGOs have seized control of the medical profession. Experts speaking out against mRNA vaccines have been de-platformed, academic journals are blocking the publication of studies showing the effectiveness of therapeutic drugs and smear campaigns are waged against any doctor or scientist who speaks out.
- Holocaust survivors have drawn stark parallels between COVID restrictions and the beginning of the holocaust, and have sent open letters to numerous regulatory agencies requesting the Nuremberg Code be followed.
- The Nuremberg Code should be accepted as international law and requires informed consent. When the UK began vaccinating residents, the vaccinated were not advised they would be taking part in a genetic medical experiment.
- The UK government failed to present citizens with current existing safe and effective alternatives for treating COVID, and pressured and manipulated them in a blatant violation of the informed consent process while intentionally concealing information regarding vaccines.
- The government did not investigate deaths, injuries or

severe damage that occurred following the administration of COVID vaccines, nor did it keep a full report of the numbers of dead or injured. The Nuremberg Code states an experiment must not be conducted when there is reason to assume death or real injury will occur.

- Petitioners accused defendants of genocide, causing massive short-term damage and death from vaccines. As of Nov. 24, 2021, 395,049 adverse events following COVID vaccines had been reported to the UK's Yellow Card reporting system. Statistical evidence suggests a massive increase in deaths following vaccination.
- Animal studies conducted in 2012-2013 to test mRNA vaccines found most animals died within 2 weeks of receiving the treatment, which is the equivalent of 1.5 years for humans.
- Several high-level immunologists including joint applicant Yeadon, have warned, in the worst possible scenario, most of the human race who have received mRNA vaccines will perish.
- The petition alleges the UK government has engaged in psychological terror and warfare in the form of mental torture, along with mainstream media and social media platforms Facebook, Twitter, YouTube and Google.
- Persecution has been carried out against the unvaccinated, who have lost jobs and been prohibited from public events, as well as religious groups who have been hindered from attending worship.
- Inhumane acts are intentionally causing great suffering and serious injury to physical and mental health. These acts include social distancing measures, mask mandates, fear-mongering, vaccination pressure, as well as vaccines themselves.
- Petitioners submit a covert war has been waged against

the people of the UK (and world) through the release of the biological weapons SARS-Cov-2 and mRNA gene therapy vaccines.

- The goal is to create a new world order, through the UN's Agenda 2030, by dismantling all the Democratic nation-states to destroy freedoms and basic human rights. The aim is to destroy small and medium businesses, moving the market shares to the largest corporations, owned by the global elite. "The fulfillment of this goal will most likely lead to the full enslavement of mankind."

"On the basis of the information available, there is a reasonable basis to believe that violations of the Nuremberg Code, genocide, crimes against humanity and war crimes have been committed," the complaint states.

"It is of the utmost urgency that ICC take immediate action, taking all of this into account, to stop the rollout of COVID vaccinations, the introduction of unlawful vaccination passports and all other types of illegal warfare mentioned herein are currently being waged against the people of the United Kingdom by way of a court injunction."
